President Sten Olsson opened the General Assembly by welcoming members and requesting approval of the agenda, as well as approval of the Agra GA minutes which were accepted by the General Assembly (the Agra GA minutes have been posted on the ISO P website).

I/ Tribute to Professor Giampaolo Velo (1943-2017)

Professor Ralph Edwards paid tribute to Professor Giampaolo Velo who passed away on 17th August in Verona (Italy).

Professor Velo was president of ISO P (2003-2006). He was professor of Pharmacology in Verona, director of the institute of pharmacology of the universities of Verona and Padova, of the regional pharmacovigilance centre of the Veneto Region. For many years, he organised meetings in beautiful Erice (Sicily) for the Fondazione Ettore Majorana, resulting in communications such as the Erice Declaration on communication in Pharmacovigilance.

The President, Board members and the Assembly observed one minute of silence to honour and remember Professor Velo.

II/ ISO P Constitution and Statutes

The President summarized the matters arising from the Extraordinary General Assembly held on the 25th of May in Bangkok. Because the quorum required for approval of statutes had not been reached at the meeting in Bangkok, the amendment of Art 8.3 and Art 15.1 of the Statutes had to be re-submitted at the next General Assembly. Accordingly, the ISO P statutes revised as of the 8th of July 2016 were submitted to the General Assembly held today (17 October 2017) and unanimously approved in a vote. Those two amendments required by *the Registre du Commerce* of Geneva in order to conform to the Swiss Law, consisted in the following:

Article 8.3: A special general assembly must be convened by the President if at least one fifth of the members wish it.

Article 15.1: Statutes can be changed only on the proposition of the Executive Committee, or as a result of a petition of at least one fifth of the members having paid their fees

Adoption of the by-laws

The President explained that the by-laws revised to adapt to the new governance structure of the Society had to be endorsed by the General Assembly. The proposed by-laws had been circulated by e-mail to all members two months before. After the President had invited for questions, the new by-law was adopted by the General Assembly.

III/ Financial report

Jean-Christophe Delumeau presented an overview of the current Society's finances prepared by the accountants in Geneva with the balance on 30th September 2017 and which stood at a reduced deficit of EUR 6,000.

The treasurer Jean-Christophe Delumeau described the general financial situation which showed incomes from successful training courses and positive financial impact when Annual Meetings take place in a High Income country.

Despite current assets in bank account increased from EUR.148'298 to EUR.153'160 (as of September 30th), there is net deficit of EUR.6'257.

Treasurer explained that for the upcoming 12 months, the goal will be to reach a positive balance of EUR.7000 in order to compensate the deficit.

He also reported back that the Executive Committee was exploring ways of payment to facilitate memberships in some countries as China or in Africa, and proposed a new structure of membership for Low/Medium Income countries:

Jean-Christophe Delumeau presented the 2018 budget and asked if there were any questions from the General Assembly.

The accounts were accepted by the General Assembly.

The Executive Committee suggests Society's membership fees to be kept unchanged for 2018. Consequently membership fees as of January 2018 will continue to be 215 EUR (with *Drug Safety* online) and 95 EUR (with *Drug Safety* online) for members from emerging countries, students and retired individuals. The proposal was approved by the General Assembly.
