

20th ISoP Annual Meeting

"Integrated pharmacovigilance for safer patients"

The 20th ISoP Annual Meeting will take place from 8 to 10 November 2021, in virtual form.

Parallel on-site activities in Muscat, Oman, are currently under consideration, and more information will be published after 30 June on the conference website.

Training courses will be organized as satellite sessions one or two weeks before or after the conference (exact dates to be confirmed).

Call for abstract submissions for the ISoP 2021 is now open, with a deadline of 21 June 2021. The scientific committee invites colleagues to submit abstracts related to pharmacovigilance and drug safety for either oral or poster presentation. Abstract acceptance notifications will be sent out on 5 August.

2021 Symposium & Training



The upcoming ISoP Symposium and Training "The societal importance of pharmacovigilance in Eurasia" is the first of its kind organised by the ISoP for healthcare professionals in this region. The training course aims to reach all those involved in ensuring the safe use of medicines in the Eurasian Economic Union (EAEU) and other countries of the Eurasian area.

This on-line symposium using the 90-minute session format will be conducted from 4-5 June 2021 and from 18 to 19 June 2021. The 4-day meeting will be conducted virtually. The programme is available at https://isoponline.org/training/symposium-and-training-eurasia/

New ISoP membership fees

Following a successful pilot in Latin America, ISoP intends to roll out worldwide the new lower fee of 35 euros for not-for-profit organisation employees from all low- and middle-income countries, and 75 euros for not-for-profit organisations from all high-income countries, effective immediately.



These adjusted membership fees are being made available because of the financial pressures brought during the time of COVID-19 pandemic and will remain in place until further notice.

Scoping Group proposal

At the 2020 ISoP AGM, ISoP President Mira Harrison-Woolrych announced the establishment of a Scoping Group to consider ideas from the Advisory Board regarding ISoP's future development.

The Group is co-chaired by Jean-Christophe Delumeau and Jan Petracek, with Board members Mónica Tarapués, Manal Younus, and Li Zhang.

To improve recognition of the ISoP as a scientific society with a strong focus on pharmacovigilance education, and to enhance its position as a global professional organization, the Scoping Group has recommended:

- * Creation of a multidisciplinary scientific board
- * Establishment of a global professional certification programme for pharmacovigilance professionals.

These two synergistic initiatives would bring significant changes to the functioning of ISoP.

Later this year, a paper from the Scoping Group will be circulated to the entire ISoP membership during a one-month consultation period, ahead of the 2021 annual General Assembly. Please be ready to read and comment on these important new developments for our society.
